I am, by direction, to inform you that Aided and Self-Financing Colleges are requested to send their proposal for sanction of 15% additional seats for all UG/PG courses in Shift-I & Shift-II for the for the academic year 2021-2022 only as per the Government order no. 143 dated 09.09.2021 issued by Higher Education Department (E2), Government of Tamil Nadu. Only on receipt of the approval from the University for additional seats, the Colleges are permitted to admit the students.

While communicating above, it is requested that the colleges who wish to apply for additional seats over and above the sanctioned strength for various UG/PG courses for the Academic Year 2021-2022 shall send their proposal on or before 01.10.2021. The Colleges applying for sanction of additional seats for Self-Financing courses (includes Aided Colleges - Shift-II Courses) should remit Rs.50,000/- +18% GST (per section/course) for UG course and Rs.40,000/-+18% GST for PG Course through online payment under the head "COLLEGE / RESEARCH INSTITUTION PAYMENTS" and nature of fees "COURSE AFFILIATION" in <http://www.unom.ac.in/online> and submit the e-receipt of the payment made along with the proposal to the University for taking necessary action. The Processing Fee is exempted for Aided Colleges for the Shift-I Courses only.

Further it is informed that the last date for admission of students to UG/PG Degree Courses in the Affiliated Arts and Science Colleges for the academic year 2021-2022 has been extended upto 06.10.2021.

The colleges are requested to send the details of the students admitted in additional seats to the Government.
