Minutes of ECRIC Committee (Ethiraj Centre for Research, Innovation and Creativity) meeting held on 24<sup>th</sup> July, 2019 at 1:00 pm at Board room, Ethiraj College for Women, Chennai.

The Deans of Research welcomed and briefed the ECRIC committee members on the background for formation of ECRIC and the road ahead in order to achieve the Vision of the management to make Ethiraj College a Centre for Research Excellence.

Eight Faculty members representing Aided and Self Supporting Streams volunteered to form the ECRIC committee along with the two deans of Research (enclosed).

The following were discussed.

- 1. Recommendations to enhance research submitted to the management on 01.02.2019 were briefed based on which the suggestions were
  - a. On a priority basis, two more lab technicians to operate high-end equipment in the FIST Centre and Instrumentation Centre are required urgently.
  - b. A single hall hosting all the Equipments has to be provided for better monitoring of the Equipments.
- 2. Subgroups were formed to frame Guidelines for the following to be submitted in the next meeting
  - a. Research Policy
  - b. Minor/Major Research Projects
  - c. Kothari Research Fellowships
  - d. Startups and incubation Centre

The next meeting was scheduled on 30.07.19.

Minutes of ECRIC Committee (Ethiraj Centre for Research, Innovation and Creativity) meeting held on 30<sup>th</sup> July, 2019 at 1:00 pm to 3:00 pm at Board room, Ethiraj College for Women, Chennai.

The following agenda were discussed.

#### 1. Research Policy was finalized

- 2. Format of Operational Guidelines released by UGC in JULY 2019 with respect to STRIDE (Scheme for Trans-disciplinary Research for India's Developing Economy) was give to the members in-charge of framing guidelines for Major/Minor projects.
- 3. Requirements for starting an incubation centre in college was discussed by the two committee members in-charge of the same Dr. M. Menaka and Ms T. Sudesna (Former E-cell Co-ordinator SS).
- 4. Need for modification of Criteria for deciding Research Excellence Award given on Founders day was discussed. The suggestions are -
- a. Application for the research excellence award to be sent by mail to IQAC and submission of copies supporting documents to be handed over to IQAC who are responsible for calculating the points for grant of the Award.
- b. Self-Supporting faculty have restrictions with respect to securing grants for research projects and therefore for research publications. They are eligible to apply only for UGC Minor Projects.
- c. Out off 25 Self-Supporting department only three have M.Phil recognition and One department has Ph.D. recognition. This makes it difficult for the Self-Supporting faculty to Publish research papers without having research scholars. Therefore the minimum cut-off points as per API guidelines for SS faculty need not be mandated.
- d. As per API guidelines the calculation of points is different for science stream Faculty and humanities and arts stream faculty. Therefore it is suggested that research excellence awards be given separately totalling to four, two each for Aided and Self-Supporting streams.
- 5. NAAC Criteria III (3.1 to 3.7) were allocated to the ECRIC committee members after discussion.
